To keep waiting times as short as possible, we ask you to notify us at least 24 hours in advance of planned and booked deliveries – for trailers at least 48 hours in advance.

Unannounced shipments will be accepted and unloaded according to the available incoming goods capacity.

DREI-D will not accept demurrage charges for any waiting times incurred as a result

The maximum stack height is 160 cm incl. pallet.

When notified the number of pallets and boxes must be stated.

Pallets:

Pallet exchange of Euro pallets: For outgoing and incoming goods, undamaged exchange pallets must be brought along and made available for exchange. Defective or non-exchangeable pallets will not be exchanged.

Packaging regulations:

Break-ins: Please mark accordingly.

Varietal purity: The pallets must be packed according to type and labeled with the respective name, packaging unit and product number.

General: DREI-D reserves the right to charge for additional costs or goods due to incorrect or improper deliveries and hidden defects/damages.

Safety precautions:

The following safety precautions must be followed on the DREI-D premises:

- ☑ Wearing personal safety shoes and vests
- ☑ Professional handling of own equipment or equipment provided by DREI-D.

non-compliance:

In the event of non-compliance with the delivery conditions, DREI-D will invoice the costs incurred as additional expenses:

- ☑ Pallet repacking due to impurity, instability or quantity control: **49,00 € per hour**
- ☑ Notification missing, too late, or no indication of the number of pallets/cartons: **55,00 €**

- ❑ Missing delivery note or bill of lading or missing information: **55,00 €**
- ❑ Cartons not labeled or missing information: **38,00 €**
