<u>Acceptance point:</u>	Suppliers please ring the bell at the window next to gate A.
<u>Further unloading points:</u>	In the case of deliveries, a warehouse employee may accompany you to one of our external warehouses.
<u>Delivery documents:</u>	Fully completed delivery notes with detailed delivery information (delivery quantity, article designation, customer designation, packaging unit and customer article number, if applicable).
<u>Delivery notification:</u>	To keep waiting times as short as possible, we ask you to notify us at least 24 hours in advance of planned and booked deliveries – for trailers at least 48 hours in advance.

The maximum stack height is 160 cm incl. pallet.

When notified the number of pallets and boxes must be
stated.

Pallets:

Pallet exchange of Euro pallets: For outgoing and incoming
goods, undamaged exchange pallets must be brought along
and made available for exchange. Defective or non-
exchangeable pallets will not be exchanged.

We ask that you only deliver on Euro pallets. Disposable one-
way pallets will need to be repacked by us. The time required
will be charged accordingly.

Packaging regulations:

Break-ins: Please mark accordingly.

Varietal purity: The pallets must be packed according to type and labeled with the respective name, packaging unit and product number.

General: Drei-D reserves the right to charge for additional costs or goods due to incorrect or improper deliveries and hidden defects/damages.

Safety precautions:

The following safety precautions must be followed on the Drei-D premises:

- » Wearing personal safety shoes and vests
- » Professional handling of own equipment or equipment provided by Drei-D.
